Cllr Scarlett asked Cllr Wilkin if he had investigated the delivery of coal to the old Carrot Wash Site and Cllr Wilkin said he had and that it had been a minor delivery, Cllr Pearson said that a resident had witnessed a large articulated truck delivering coal to this site and it caused a significant amount of dust in the area. Cllr Wilkin asked that when this happens again to contact him and he will get the Planning Enforcement Officer involved.

7. MATTERS ARISING

7.1 OUTSTANDING HIGHWAY MATTERS

Cllr Lyndsay pointed out that the road markings at the junction of Browns Lane and Station Road had not been renewed following the resurfacing of the road, Cllr McBrien said he had queried this with Highways team and they had confirmed that they will be renewed but not until a certain amount of time has passed following the resurfacing.

Church Road - adjacent to the Village Green - there are 2 pot holes

Church Lane – between numbers 4 and 7 - 2 pot holes

Following a discussion, it was agreed that the Clerk would contact Highways regarding the recent Rangers visit as the speed signs have not been cleaned and the reflector posts on Station Road are still leaning over and need to be straightened.

7.2 PERMISSIVE FOOTPATHS AND BRIDLEWAYS

Following a subcommittee meeting held in August, Cllr Scarlett had a further meeting with Broke Brothers Farms and a proposal had been put forward with details on what the Parish Council were prepared to contribute to the maintenance of the footpaths and this is currently being considered by Broke Brothers. It is hoped that an agreement is reached before the dead line which is the end of September and Cllr Scarlett said that he will report back as soon as he has received any news on the situation.

7.3 RISK ASSESSMENT AND HEALTH AND SAFETY POLICY 2019

Cllr Lyndsay and the Clerk carried out a risk assessment on the Councils assets in August and the following points were raised.

Grit bins – there was 6 on the original asset list and there are now only 4, Cllr Scarlett said that in 2014 6 old wooden grit bins were replaced with 4 plastic bins. It was noticed that these plastic bins are swelling at the front with the weight of the grit inside them, the lid of the bin at the junction of Station Road and Browns Road had become loose due to the hinge rod which is broken and the ends are missing.

Extra Village Sign on poles at the junction of Station Road and Browns Road needs to be removed as this has been replaced by the new sign on a brick plinth.

Dog bin in Red Lion Close – lid is missing.

Litter bin St Andrews Close – lid is missing and this is also being used as a dog waste bin. (*The Clerk will put a notice in the Moonraker asking dog owners to only use the designated dog bins for their waste and not the litter bins*)

Bench on the Village Green -2 screws are missing.

Following a discussion it was agreed that the Risk Assessment would not be signed off at this meeting and that Cllr Scarlett and Cllr Pearson would attempt to carry out the various repairs before the next meeting, it was also agreed that an extra column would be added on the risk assessment form so that it could be noted when the various repairs have been carried out.

Health and Safety Policy Statement – this had been circulated to the Councillors prior to the meeting and this was signed off by Cllr A. Scarlett.

7.4 STANDING ORDERS – review and agree updated Standing Orders (last reviewed in 2015)

Following a discussion regarding the visual impact of the building and that it will be more visually noticeable to Holme Hale rather than Necton the Parish Council requested to Cllr Wilkin that representatives from both Holme Hale and Necton Parish Councils are involved in the consultation regarding the screening of the building.
