Cllr Eagle (county councillor) reported in regard to the second verge cut (which was in relation to an email sent on behalf of the parish council) Last year originally NCC were doing only one cut plus a residual cut, so all the main roads were being cut with the minor roads only having the junctions cut. The main cut was done in May. The second cut which Cllr Eagle contributes to (with his contribution classed as junction improvement and focusing on road safety around July). He will push for the second cut, which is felt by a number of people necessary in rural areas, however there is some resistance from groups whose focus is on wildlife.

The NCC budgets are in consultation. You are unlikely to be surprised that council taxes are going up, not as much as the officers recommendation but it is going up. Central government has offered us £2m less funding than what we have had in the previous 10 years.

Cllr Eagle's highway budget has been increased. He has purchased some L-shape light weight flood barriers. If the parish has any issues, then they are there and available.

Cllr Eagle then took questions, during questions Cllr Eagle made the council aware that if they have emergency highways repairs such as drains jetted then they can forward the invoice to Norfolk County Council. Cllr Wilkins (district councillor) absence was discussed again by the parish council. Cllr Eagle to speak to Cllr Wilkins on parish council's behalf if he sees him elsewhere.

Cllr Eagle left after reporting.
