Cllr Scarlett reported (for information only) that there had been an independent design review which was mentioned at the last meeting. A report has since come back from that meeting and has been circulated to all councillors. The outcome of which was that the Secretary of States conditions hadn't been met and as far as the design review was concerned Vattenfall should appoint an architect, review its submissions, revise the size of buildings and minimise its impact on the environment.

A number of days ago Cllr Scarlett along with representatives from Necton PC met with the director of planning and building control at Breckland Council where they were introduced to the case officer. They are led to believe that there have been meetings between Breckland and Vattenfall and that Breckland have supplied Vattenfall with a list of concerns.

There was another meeting in the last week between Breckland and Vattenfall. The case officer stated he was prepared to have meetings with the parish councils in the future. He was asked if there would be another design review of which is was unsure of the legal requirement. As an aside the national grid has put in for an extension of their extension. There was to be an extension of the existing national grid substation for Dudgeon in order to accept the input from Vanguard and Boreas. Breckland have received the application for this extension to the extension, however it would appear that the extension had not passed before Breckland.

Necton PC have engaged via the environmental law foundation the assistance of a barrister. Necton have permitted HHPC representatives to sit in on these meetings.

We have been asked to give comments on the national grid extension to the extension, it is not formally as it falls outside of Holme Hale.

Those 11 applicants are in the process of receiving funds.

In light of a number of government schemes further promotion of HHFAT is not planned and this will be reviewed in Spring 2023.

Any resident may apply at any point in the year to HHFAT, for any type of hardship. The focus on fuel has only been in the last year due to the vast increase in costs.
