#### **HOLME HALE PARISH COUNCIL**

### **STANDING ORDERS**

Approved: 4<sup>th</sup> March 2024 Reviewed 3-yearly or when required.

**Bold type** signifies orders which contain legal and statutory requirements, so must be retained.

The Clerk is referred to as the Proper Officer. It is assumed that they are also the Responsible Financial Officer.

Financial Regulations are not included in Standing Orders other than regulations relating to contracts. This is required by Local Government Act 1972.

A councillor should be given a copy of Standing Orders or know where to find them on the Council's website.

### 1. RULES OF DEBATE AT MEETINGS

- a) Motions on the agenda shall be considered in the order that they appear unless the order is changed at the discretion of the chairman of the meeting.
- **b)** To ensure clarity only one motion may be moved at any one time.
- c) A motion (including an amendment) must have a proposer and a seconder.
- **d)** An amendment is a proposal to remove or add words to a motion. It shall not negate the motion.
- **e)** A point of order shall be decided by the Chairman of the meeting and his decision shall be final.
- **f)** Discussion shall always be addressed to the Chairman, who controls debate.

# 2. DISORDERLY CONDUCT AT MEETINGS

a) No person shall obstruct the transaction of business at a meeting or behave offensively or improperly. If this standing order is ignored, the Chairman of the meeting shall request such person(s) to moderate or improve their conduct and failing this be excluded from the meeting.

# 3. MEETINGS GENERALLY

 a) Meetings shall not take place in premises which at the time of the meeting are used for the supply of alcohol, unless no other premises are available free of charge or at a reasonable cost.

- b) The minimum three clear days for notice of a meeting does not include the day on which notice was issued, the day of the meeting, a Sunday, a day of the Christmas break, a day of the Easter break or of a bank holiday or a day appointed for public thanksgiving or mourning.
- c) The minimum three clear days' public notice for a meeting does not include the day on which the notice was issued or the day of the meeting unless the meeting is convened at shorter notice.
- d) Meetings shall be open to the public unless their presence is prejudicial to the public interest by reason of the confidential nature of the business to be transacted or for other special reasons. The public's exclusion from part or all of a meeting shall be by a resolution which shall give reasons for the public's exclusion.
- e) Public participation shall be included on the agenda for a maximum of 15 minutes unless directed by the Chairman. Comments must be directed to the Chairman
- **f)** A question posed by a member of the public need not be answered or start a debate. The Chairman may direct when a written or oral reply will be given.
- g) A person who attends a meeting is permitted to report on the meeting whilst the meeting is open to the public. To "report" means to film, photograph, make an audio recording of meeting proceedings, use any other means for enabling persons not present to see or hear the meeting as it takes place or later or to report or to provide oral or written commentary about the meeting so that the report or commentary is available as the meeting takes place or later to persons not present. A person present at a meeting may not provide an oral report or oral commentary about a meeting as it takes place without permission.
- h) The press shall be provided with reasonable facilities for the taking of their report of all or part of a meeting at which they are entitled to be present.
- i) Subject to standing orders which indicate otherwise, anything authorised or required to be done by, to or before the Chairman of the Council may in their absence be done by, to or before the Vice-Chairman of the Council (if there is one).
- j) The Chairman of the Council, if present, shall preside at a meeting. If the Chairman is absent from a meeting, the Vice-Chairman of the Council (if there is one) if present, shall preside. If both the Chairman and the Vice-Chairman are absent from a meeting, a councillor as chosen by the councillors present at the meeting shall preside at the meeting.
- k) Subject to a meeting being quorate, all questions at a meeting shall be decided by a majority of the councillors and non-councillors with voting rights present and voting.
- The Chairman of a meeting may give an original vote on any matter put to the vote, and in the case of an equality of votes may exercise their casting vote whether or not

## they gave an original vote.

See standing orders 5(h) and (i) for the different rules that apply in the election of the Chairman of the Council at the annual meeting of the Council.

- m) Unless standing orders provide otherwise, voting on a question shall be by a show of hands. At the request of a councillor, the voting on any question shall be recorded so as to show whether each councillor present and voting gave their vote for or against that question.
- n) The minutes of a meeting shall include an accurate record of the following:
  - i. the time and place of the meeting;
  - **ii.** the names of councillors who are present and the names of councillors who are absent;
  - **iii.** interests that have been declared by councillors and non-councillors with voting rights;
  - iv. the grant of dispensations (if any) to councillors and non-councillors with voting rights;
  - **v.** whether a councillor or non-councillor with voting rights left the meeting when matters that they held interests in were being considered;
  - vi. if there was a public participation session; and
  - vii. the resolutions made.
- o) A councillor or a non-councillor with voting rights who has a disclosable pecuniary interest or another interest as set out in the Council's code of conduct in a matter being considered at a meeting is subject to statutory limitations or restrictions under the code on their right to participate and vote on that matter.
- p) If a meeting is or becomes inquorate no business shall be transacted and the meeting shall be closed. The business on the agenda for the meeting shall be adjourned to another meeting.
- **q)** A meeting shall not exceed a period of two hours.

# 4. COMMITTEES AND ADVISORY GROUPS

- a) The council may appoint a committee whose terms of reference and members shall be determined by the council. A committee will meet in public and have an agenda and minutes. Financial matters are excluded from committees. The quorum of a committee must be no less than three members made up from councillors.
- b) The council may appoint an advisory group who need not meet in public. The council https://holmehaleparishcouncil.norfolkparishes.gov.uk/

will determine their terms of reference.

## 5. ORDINARY COUNCIL MEETINGS

- a) In an election year, the annual meeting of the Council shall be held on or within 14 days following the day on which the councillors elected take office.
- **b)** In a year which is not an election year, the annual meeting of the Council shall be held on such day in May as the Council decides.
- c) If no other time is fixed, the annual meeting of the Council shall take place at 6 pm.
- d) In addition to the annual meeting of the Council, at least three other ordinary meetings shall be held in each year on such dates and times as the Council decides.
- e) The first business conducted at the annual meeting of the Council shall be the election of the Chairman and Vice-Chairman (if there is one) of the Council.
- f) The Chairman of the Council, unless they have resigned or become disqualified, shall continue in office and preside at the annual meeting until their successor is elected at the next annual meeting of the Council.
- g) The Vice-Chairman of the Council, if there is one, unless they resign or becomes disqualified, shall hold office until immediately after the election of the Chairman of the Council at the next annual meeting of the Council.
- h) In an election year, if the current Chairman of the Council has not been re-elected as a member of the Council, they shall preside at the annual meeting until a successor Chairman of the Council has been elected. The current Chairman of the Council shall not have an original vote in respect of the election of the new Chairman of the Council but shall give a casting vote in the case of an equality of votes.
- i) In an election year, if the current Chairman of the Council has been re-elected as a member of the Council, they shall preside at the annual meeting until a new Chairman of the Council has been elected. They may exercise an original vote in respect of the election of the new Chairman of the Council and shall give a casting vote in the case of an equality of votes.
- j) Following the election of the Chairman of the Council and Vice-Chairman (if there is one) of the Council at the annual meeting, the business shall include:
  - i. In an election year, delivery by the Chairman of the Council and councillors of their acceptance of office forms unless the Council resolves for this to be done at a later date. In a year which is not an election year, delivery by the Chairman of the Council of their acceptance of office form unless the Council resolves for this to be done at a later date;
  - ii. Confirmation of the accuracy of the minutes of the last meeting of the Council;

iii. In an ordinary election year, and where applicable, to confirm the Council's eligibility to exercise the general power of competence in the future.

### 6. EXTRAORDINARY MEETINGS OF THE COUNCIL

- The Chairman of the Council may convene an extraordinary meeting of the Council at any time.
- b) If the Chairman of the Council does not call an extraordinary meeting of the Council within seven days of having been requested in writing to do so by two councillors, any two councillors may convene an extraordinary meeting of the Council. The public notice giving the time, place and agenda for such a meeting shall be signed by the two councillors.

#### 7. PREVIOUS RESOLUTION

a) A resolution shall not be reversed within six months except either by a special motion, which requires written notice by at least three councillors to be given to the Proper Officer.

### 8. VOTING ON APPOINTMENTS – CO-OPTION OF A NEW COUNCILLOR

a) Where more than two persons have been nominated and none of those persons has received an absolute majority of votes in their favour, the name of the person having the least number of votes shall be struck off the list and a fresh vote taken. A tie in votes may be settled by the casting vote exercisable by the chairman of the meeting.

# 9. MOTIONS FOR A MEETING THAT REQUIRE WRITTEN NOTICE TO BE GIVEN TO THE PROPER OFFICER

- a) A motion shall relate to the responsibilities of the meeting for which it is tabled and, in any event, shall relate to the performance of the Council's statutory functions, powers and obligations or an issue which specifically affects the Council's area or its residents.
- **b)** No motion may be moved at a meeting unless it is on the agenda and the mover has given written notice of its wording to the Proper Officer at least seven clear days before the meeting.
- c) The Proper Officer and the Chairman will decide on whether or not to include any motion on the agenda. An explanation, if requested, on its exclusion shall be given by the Proper Officer. A motion received which is not clear in meaning will be rejected by the Proper Officer.

## 10. MOTIONS AT A MEETING THAT DO NOT REQUIRE WRITTEN NOTICE

- a. The following motions may be moved at a meeting without written notice to the Proper Officer:
  - i. to correct an inaccuracy in the draft minutes of a meeting;

- ii. to move to a vote;
- iii. to defer consideration of a motion;
- iv. to refer a motion to a committee (if applicable);
- v. to appoint a person to preside at a meeting;
- vi. to change the order of business on the agenda;
- vii. to proceed to the next business on the agenda;
- viii. to require a written report;
- ix. to appoint a committee or sub-committee and their members;
- x. to extend the time limits for speaking;
- xi. to exclude the press and public from a meeting in respect of confidential or other information which is prejudicial to the public interest;
- xii. to not hear further from a councillor or a member of the public;
- xiii. to exclude a councillor or member of the public for disorderly conduct;
- xiv. to temporarily suspend the meeting;
- xv. to suspend a particular standing order (unless it reflects mandatory statutory or legal requirements);
- xvi. to adjourn the meeting or to close the meeting.

#### 11. MANAGEMENT OF INFORMATION

- a) The Council shall have in place and keep under review, technical and organisational measures to keep secure information (including personal data) which it holds in paper and electronic form. Such arrangements shall include deciding who has access to personal data and encryption of personal data.
- b) The Council shall have in place, and keep under review, policies for the retention and safe destruction of all information (including personal data) which it holds in paper and electronic form. The Council's retention policy shall confirm the period for which information (including personal data) shall be retained or if this is not possible the criteria used to determine that period (e.g., the Limitation Act 1980).
- c) The agenda, papers that support the agenda and the minutes of a meeting shall not disclose or otherwise undermine confidential information or personal data without legal justification.

d) Councillors, staff, the Council's contractors and agents shall not disclose confidential information or personal data without legal justification.

#### 12. DRAFT MINUTES

- a) If the draft minutes of a preceding meeting have been served on councillors with the agenda to attend the meeting at which they are due to be approved for accuracy, they shall be taken as read.
- **b)** There shall be no discussion about the draft minutes of a preceding meeting except in relation to their accuracy.
- c) The accuracy of draft minutes, including any amendment(s) made to them, shall be confirmed by resolution and shall be signed by the Chairman of the meeting and stand as an accurate record of the meeting to which the minutes relate.
- **d)** If the Chairman of the meeting does not consider the minutes to be an accurate record of the meeting to which they relate, they shall sign the minutes and include a paragraph to this effect.
- e) If the Council's gross annual income or expenditure (whichever is higher) does not exceed £25,000, it shall publish draft minutes on a website which is publicly accessible and free of charge not later than one month after the meeting has taken place.
- **f)** Any notes or recordings taken at a meeting shall be destroyed once the minutes have been confirmed.

## 13. CODE OF CONDUCT AND DISPENSATIONS

- a) All councillors shall observe the code of conduct adopted by the Council. Details regarding this are contained in the Council's Code of Conduct Policy document.
- b) Dispensation requests shall be in writing and submitted to the Proper Officer as soon as possible before the meeting, or failing that, at the start of the meeting for which the dispensation is required. Any request shall be considered by the Proper Officer of the Council.
- c) A dispensation may be granted in accordance with standing order 13(b) if having regard to all relevant circumstances any of the following apply:
  - without the dispensation the number of persons prohibited from participating in the particular business would be so great a proportion of the meeting transacting the business as to impede the transaction of the business;
  - ii. granting the dispensation is in the interests of persons living in the Council's area; or

iii. it is otherwise appropriate to grant a dispensation.

## 14. CODE OF CONDUCT COMPLAINTS

a) Upon notification by the District Council that it is dealing with a complaint that a councillor has breached the Council's code of conduct, the Proper Officer shall advise the Council and forward the complaint to the Monitoring Officer.

#### 15. PROPER OFFICER

- a) The roles, responsibilities and duties of the Proper Officer are contained in a job description. A Contract of Employment and Job Description will be issued at the start of the employment period.
- b) The Proper Officer will include the issuing of summonses and advertising of the agenda within the time frame detailed in law.
- c) Delegation to the Proper Officer (Local Government Act 1972 s101). The Proper Officer has the authority of Council to spend up to £500 in the event of an emergency. The Chairman or Vice-Chairman (if the Chairman is absent) must be notified.

# 16. RESPONSIBLE FINANCIAL OFFICER (RFO)

**a)** The Council must appoint a RFO. The duties of the RFO will be defined in a Job Description.

## 17. ACCOUNTS AND ACCOUNTING STATEMENTS

a) The RFO will conduct all financial matters according to "proper practices" the detail of which is contained in the Job Description. These duties are detailed in the Accounts & Audit Regulations 2015 and in Governance & Accountability for the relevant year.

# 18. FINANCIAL CONTROLS AND PROCUREMENT

- a) The Council shall consider and approve financial regulations drawn up by the Responsible Financial Officer, which shall include detailed arrangements in respect of the following:
  - i. the keeping of accounting records and systems of internal controls;
  - ii. the assessment and management of financial risks faced by the Council;
  - iii. the work of the independent internal auditor in accordance with proper practices and the receipt of regular reports from the internal auditor, which shall be required at least annually;
  - iv. the inspection and copying by councillors and local electors of the Council's accounts and/or orders of payments; and

- v. whether contracts with an estimated value below £25,000 due to special circumstances are exempt from a tendering process or procurement exercise.
- **b)** Financial regulations shall be reviewed regularly and at least annually for fitness of purpose.
- c) A public contract regulated by the Public Contracts Regulations 2015 with an estimated value in excess of £25,000 but less than the relevant thresholds referred to in standing order 18(f) is subject to the "light touch" arrangements under Regulations 109-114 of the Public Contracts Regulations 2015 unless it proposes to use an existing list of approved suppliers (framework agreement).
- **d)** Subject to additional requirements in the financial regulations of the Council, the tender process for contracts for the supply of goods, materials, services or the execution of works shall include, as a minimum, the following steps:
  - i. a specification for the goods, materials, services or the execution of works shall be drawn up;
  - ii. an invitation to tender shall be drawn up to confirm (i) the Council's specification (ii) the time, date and address for the submission of tenders (iii) the date of the Council's written response to the tender and (iv) the prohibition on prospective contractors contacting councillors or staff to encourage or support their tender outside the prescribed process;
  - iii. the invitation to tender shall be advertised in a local newspaper and in any other manner that is appropriate;
  - iv. tenders are to be submitted in writing in a sealed marked envelope addressed to the Proper Officer;
  - v. tenders shall be opened by the Proper Officer in the presence of at least one councillor after the deadline for submission of tenders has passed;
  - vi. tenders are to be reported to and considered by the appropriate meeting of the Council or a committee or sub-committee with delegated responsibility.
- e) Neither the Council, nor a committee or a sub-committee with delegated responsibility for considering tenders, is bound to accept the lowest value tender.
- f) Where the value of a contract is likely to exceed the threshold specified by the Office of Government Commerce from time to time, the Council must consider whether the Public Contracts Regulations 2015 or the Utilities Contracts Regulations 2016 apply to the contract and, if either of those Regulations apply, the Council must comply with procurement rules. NALC's procurement guidance contains further details.

#### 19. HANDLING STAFF MATTERS

a) A matter personal to a member of staff that if being considered by a meeting of Council shall be considered in private. Written records of meetings and other staffing matters will also be treated as confidential.

### 20. RESPONSIBILITIES TO PROVIDE INFORMATION

- a) In accordance with freedom of information legislation, the Council shall publish information in accordance with its publication scheme and respond to requests for information held by the Council.
- b) The Council shall publish information in accordance with the requirements of the Smaller Authorities (Transparency Requirements) (England) Regulations 2015.

### 21. RESPONSIBILITIES UNDER DATA PROTECTION LEGISLATION

- a) The Council shall have policies and procedures in place to respond to an individual exercising statutory rights concerning their personal data.
- b) The Council shall have a written policy in place for responding to and managing a personal data breach.
- c) The Council shall keep a record of all personal data breaches comprising the facts relating to the personal data breach, its effects and the remedial action taken.
- d) The Council shall ensure that information communicated in its privacy notice(s) is in an easily accessible and available form and kept up to date.
- e) The Council shall maintain a written record of its processing activities.

## 22. RELATIONS WITH THE PRESS/MEDIA

a) Requests from the press or other media for an oral or written comment or statement from the Council, shall be dealt with by the Chairman.

# 23. EXECUTION AND SEALING OF LEGAL DEEDS

a) A legal deed shall not be executed on behalf of the Council unless authorised by a resolution. It must be signed by two councillors and witnessed by the Proper Officer.

### 24. COMMUNICATING WITH DISTRICT AND COUNTY COUNCILLORS

a) An invitation to attend a meeting of the Council shall be sent, together with the agenda, to these councillors representing the area of the Council.

### 25. PLANNING

- a) The Parish Council believes that its constituents are best served by the Parish Council responding to applications in a timely fashion.
- **b)** Where possible, all applications will be considered at an ordinary meeting. Extensions to allow this to happen will be requested if the timescales are reasonable.
- c) In the event a meeting is not taking place within the required planning time frame, and an extension cannot be obtained, and to ensure that consultations on planning applications are dealt with in time, the Parish Council has delegated authority to the Clerk to respond on behalf of the Council, following consultation with all Council members (by email). Council members must respond within the time-scale in the email sent for comments by the Clerk.
- **d)** The decision of the Clerk will be taken in liaison with the Chairman.
- e) In respect of any contentious applications, any Council member can request that the Chairman call an extra-ordinary meeting to discuss the application in public. This must be requested within the time-scale as set out in the email for comments sent from the Clerk.
- f) All decisions will be reported at the next ordinary Council meeting.
- g) Standard Light Clause the Parish Council commends the control of obtrusive light and the reduction of sky glow in order to enhance conditions for nocturnal wildlife and prevent light pollution in Holme Hale. When responding to any planning application that may use lighting in its design, the Council will attach the following to every response, so that the planning authority is encouraged to insert conditions restricting the use of outdoor lighting should planning permission be granted.

'National Planning Policy Framework (NPPF) Clause 191c and Norfolk County Council's Environmental Lighting Zones Policy both recognise the importance of preserving dark landscapes and dark skies. In order to minimise light pollution, we recommend that, if this application is permitted, any outdoor lights associated with the proposed development should be:

- Fully shielded (enclosed in full cut-off flat glass fitments)
- Directed downwards (mounted horizontally to the ground and not tilted upwards)
- Switched on only when needed (no dusk to dawn lamps)
- White light low-energy lamps (preferably LEDs, ideally with a colour temperature of 3,000K or 3,500K) and not orange or pink sodium sources.'

### 26. RESTRICTIONS ON COUNCILLOR ACTIVITIES

a) Unless duly authorised no councillor shall inspect any land and/or premises which the Council has a right or duty to inspect or issue orders, instructions or directions. No individual councillor has delegated authority to act on behalf of the Council.

### 27. STANDING ORDERS GENERALLY

- a) All or part of a standing order, except one that incorporates mandatory statutory or legal requirements, may be suspended by resolution in relation to the consideration of an item on the agenda for a meeting.
- **b)** The Proper Officer shall review Standing Orders and make recommendation to the Council on any changes.
- c) The decision of the Chairman of a meeting as to the application of standing orders at the meeting shall be final.
